## UPCOMING APPROVED ADDITIONAL TRAINING OPPORTUNITIES OPEN TO VIRGINIA ANIMAL CONTROL OFFICERS

Virginia Code § 3.2-6556 requires every animal control officer to complete 15 hours of additional training in animal control and protection every three years, and requires all training courses to be approved by the State Veterinarian. The State Veterinarian's criteria used to approve training require training providers or participants to submit a request form for course approval.
