Additional Charges

A. Calibration services requiring work to be performed outside the regular work area will include charges for travel time, mileage, and expenses incurred. For services requested, the fee shall be based on the following:

1- Hourly Rate:		Fee Per Unit \$50.00
2- Vehicle Mileage:	Cars	IRS Standard Mileage Rate for business miles
3- Pick-up trucks		IRS Standard Mileage Rate for business miles
4- Calibration Unit		negotiable
5- Large Capacity Scale Testing Unit		negotiable

B. Calibration services requiring additional documentation beyond the normal one original certificate will be provided at the charge of \$8.00 per document.

C. If a standard requires adjustment, the fee for that standard will be double the fee per unit listed above.

D. Standard owners are responsible for all shipping charges.
