



Instructions for completing the Infrastructure Form

This guide helps you complete the Infrastructure Loss form by providing step-by-step instructions on the information required and how to enter it in the system. After completing Registration and selecting a Funding Opportunity, start a new application and enter general information. You will then be taken to the Application Details page. From the **Application Details** page, click on **Infrastructure Loss** from the list of forms.

Step 1 – Indicate Infrastructure Loss

On the **Infrastructure Loss** form,

- Select **Yes** if you experienced Infrastructure losses due to the storm. Click **Save Form**.
- If **No**, click **Save Form** and **Mark as Complete**. No further action is required for this form.

Infrastructure Loss - Current Version

All forms automatically open in "Edit" mode the very first time you go into the form. After that you have to click "Edit" to go into Edit mode.
Some sections like a multi list do not open in Edit mode you can add many rows using the "Add" button. **The form must be "Mark As Complete" before submitting the application.**

- Must be an Eligible Producer.
 - Subpart A: On-Farm Building Structures.
 - Eligible on-farm building structures include, but are not limited to barns, silos, and greenhouses.
 - The eligible structures must have suffered at least a 15 percent loss (damage) as a result of Hurricane Helene.
 - The structure is not required to have a commodity or livestock present at the time Hurricane Helene hit as long as there is evidence that commodities or livestock were present within the 12 months prior to Hurricane Helene.
 - The eligible structure must be located in an eligible locality.
 - Ineligible structures include, but are not limited to equipment buildings, repair shops, and movable equipment.
 - Subpart B: On-Farm Roads, Bridges, and Culverts.
 - Eligible roads, bridges, and culverts must provide direct access to farm production and be located on the farm.
 - To be eligible they must have suffered significant damage, such as a complete washout and be impassable or nearly impassable.
 - The eligible roads, bridges, and culverts must be located in an eligible locality.
 - Roads, bridges, and culverts located on forest land are not eligible.

Step 2 – Add Infrastructure Loss Entry

1. If Yes was selected for losses, Click **Add Entry**.

If you are reporting infrastructure losses, you will need to complete a separate entry for each property with damage. If multiple infrastructure types were damaged on the same property, each type will require its own entry.
