Federal Grain Inspection Service (FGIS) must approve all fees for official services and Official Agencies will access only those fees appearing on their current approved fee schedule. Federal Grain Inspection Fees (see FGIS Directive 9180.74 – Attachment #2) will be assessed in addition to all other charges when applicable.

 1/2 hour minimum per corrected document.

Service requests not covered by the above fees will be assessed the hourly rate of \$55.00 for regular time and \$60.00 for overtime.

OFFICIAL SERVICES include, but are not limited to grading, weighing, sampling, stowage examination and certification under the United States Grain Standards Act.

OFFICIAL COMMERCIAL INSPECTION SERVICES will be negotiated on a case-by-case basis.

HOURLY CHARGES will be assessed in one half hour increments.

STANDBY, DOWNTIME, CANCELLATIONS, CHANGES TO ORIGINAL SCHEDULING which may occur through no fault of VDACS will be assessed at the applicable hourly rate **per employee**. A **minimum of four hours** standby time per employee will be assessed for requested service when services cannot be performed through no fault of VDACS. This includes any changes or cancellations not made in accordance with the Scheduling Requirements for Service Requests policy.

MILEAGE The IRS standard mileage rate will be assessed per mile actual miles traveled plus travel time. Any change to the mileage rate is effective when the IRS changes their standard mileage rate. Mileage and travel time will be prorated when it is possible.

TRAVEL TIME will be \$55.00 per hour per employee

PER DIEM Motel expense plus state allowance for meals when personnel are required to remain overnight away from employee's base of employment.

MAILING OF SAMPLES Actual cost of shipping/delivery.

HOLIDAYS are days established by the Commonwealth: New Year's Day, M.L. King Day, Washington's Birthday, Memorial Day, Juneteenth, Independence Day, Labor Day, Columbus Day, Election Day, Veterans Day, Thanksgiving Day and the following Friday, Christmas Day and those granted by the Executive Order of the Governor of the Commonwealth.

PAYMENT FOR SERVICES The Code of Virginia authorizes the Department of Agriculture and Consumer Services to charge interest, late fees, collection costs and/or administrative costs and to deny services on past due accounts.

A \$20 fee will be assessed on each returned check.
