How did you do? According to the Virginia Department of Agriculture and Consumer Services, agriculture is the state's largest industry, contributing \$52 billion to the state's economy every year. Our dairy farms support 96,000 dairy cows and there are more than 46,000 thousand farms of all kinds in the state.

On Question 4, category #4, the one that contains industrial hemp, lists a product not currently grown in Virginia. This may change in the near future; the 2015 General Assembly passed a bill allowing research into growing hemp as a crop in the state. Also, while individuals may grow carrots, they are not a commercial crop in the state.

Virginia currently has 1,312 Century Farms; soybeans are our largest export product and broilers are the #1 product. Question 8 is tricky; all four products hold national rankings: leaf tobacco ranks 3rd, fresh market tomatoes are 5th, and apples and turkeys both rank 6th.

Nearly 90 percent of farms in Virginia are family-owned and operated and farms cover 32 percent of Virginia's land mass.
