**EXEMPTION FROM FOOD SAFETY PERMIT & INSPECTION for RETAILERS SELLING EDIBLE HEMP PRODUCTS**  
 DOWNLOAD THIS APPLICATION TO YOUR COMPUTER AND OPEN IN ADOBE READER FOR FULL FUNCTIONALITY

Pursuant to the Code of Virginia § 3.2-5145.2:1 (B), any person who offers for sale an edible hemp product must first obtain a permit from the Virginia Department of Agriculture and Consumer Services Food Safety Program, unless EXEMPT from a permit pursuant to subdivision C 6 of § 3.2-5130.

**THIS EXEMPTION IS LIMITED TO RETAIL ESTABLISHMENTS THAT MEET ALL OF THE FOLLOWING CRITERIA:**

- (a) Compliant with Article 5 of the Virginia Food and Drink Law;
- (b) Sell only food or beverages that are sealed in packaging by the manufacturer and come from an approved/inspected source;
- (c) Do not prepare or serve food;
- (d) Do not offer beverage service (i.e. coffee pot, fountain drink machine);
- (e) Do not sell infant formula;
- (f) Do not sell salvaged foods;
- (g) Do not sell unwrapped produce;
- (h) Do not sell store packaged ice;
- (i) Do not offer self-service of unwrapped foods (i.e. donut cases, bulk nuts, pickles);
- (j) Do not sell food or beverages, including edible hemp products, to other businesses for resale (wholesale); and
- (k) Certify to the Virginia Department of Agriculture and Consumer Services that they meet the foregoing criteria.

Please note that firms qualifying for the exemption are still obligated to comply with the Virginia Food and Drink Law and the **Regulations Governing the Manufacturing and Sale of Products that Contain Industrial Hemp Extracts Intended for Human Consumption**. Nothing in this language shall prevent the Virginia Department of Agriculture and Consumer Services from inspecting any retail establishment if a consumer complaint is received or if an investigation is warranted.
