

2024 Virginia Organic Certification Cost Share Program
Qualifying Period: October 1, 2023 – September 30, 2024

The Virginia Department of Agriculture and Consumer Services (VDACS) has just received approval by the United States Department of Agriculture's (USDA) National Organic Program (NOP) for funding through the National Organic Certification Cost Share Program (OCCSP). The OCCSP funds will provide reimbursement to eligible organic growers and processors for 75 percent of their 2023-2024 organic certification costs up to a maximum of \$750 per category of certification.

The reimbursements will be for those who have successfully completed their organic certification from a USDA accredited organic certifying agency between October 1, 2023, and September 30, 2024. **All paperwork must be submitted to VDACS no later than November 30, 2024.** Funds will be distributed on a first-come, first-served basis until they have been depleted.

The application must contain the following:

2. Commonwealth of Virginia (COV) W-9 tax form with original physical signature, which can be found here: https://www.doa.virginia.gov/forms/CVG/W9_COVSubstitute.pdf. NOTE: For security reasons, if you use your social security number (SSN) as your business identifier, **do not email the completed COV W-9 with the SSN**; please mail the completed form to the address listed on the application;
3. Current copy of the applicant's organic certificate from an accredited certification agency;
4. Itemized receipt(s) from the certifier detailing the total cost of services rendered and showing the date of payment within the program time-frame.
