Class I Skim Price = Prevailing market Net Skim Price + Milk Commission Adjustment per Regulation 2VAC15-20-81. Prevailing Market Net Skim Price = USDA AMS Base Skim Milk Price for Class I + USDA location differential + Prevailing Market Over Order Premium

Prevailing Market Over Order Premium = The difference in the reported price paid by processors for raw milk in select markets and the announced USDA Base Class I Price

Class I Butterfat Price = USDA AMS Advanced Butterfat Pricing Factor + (USDA location differential \div 100) + (Prevailing Market Over Order Premium \div 100)
