The Virginia Tobacco Board

I. Narrative

The Virginia Tobacco Board was established under § 3.2 – 2400 to 2411 of the Code of Virginia on July 1, 2012, merging the Virginia Bright Flue-Cured and Virginia Dark-Fired Tobacco Boards into a single Virginia Tobacco Board. The Virginia Tobacco Board manages two separate funds: the Bright Flue-Cured Tobacco Promotion Fund and the Virginia Dark-Fired Promotion Fund. Each of these programs provide funding for the promotion, education, and research of these two types of Virginia-produced tobacco. The Virginia Tobacco Board received \$111,595.98 in excise taxes into the Bright Flue-Cured Promotion Fund and \$745.08 into the Dark-Fired Promotion Fund in fiscal year 2023-2024.

The Board had actual expenditures of \$116,712.40 from the Bright Flue-Cured Promotion Fund, and \$1,539.10 from the Dark-Fired Fund during the fiscal year. Of this amount, \$118,251.50, 99 percent of expenditures was spent on various projects involving market development, promotion, research, or education for the purpose of increasing the demand for Virginia-produced tobacco. Tobacco Associates, Inc., by contractual agreement with the Board, received \$46,000 for the purpose of conducting flue-cured tobacco market development and promotion in foreign countries. Funds were provided for seven Virginia Cooperative Extension Southern Piedmont Agricultural Research & Extension Center production research projects and the 2025 Flue-cured Tobacco Production Guide, totaling \$75,419.

The Board ended the fiscal year with a cash balance of \$129,148.51, including a reserve of \$40,000, in the Flue-Cured Promotion Fund and \$387.89 in the Dark-Fired Fund. As of June 30, 2024, the Board had future financial commitments of \$84,687.51. These commitments are for research and education projects awarded funds for the 2024-2025 fiscal year. The excise tax assessment has remained at \$.40 per one hundred pounds.
